Chairman Thurman called the meeting to order at 9:00 a.m.

Kim Kapin, Clerk of the Board, called roll and informed the Chairman a quorum had been met.

Supervisor Smith announced that Michael Flannery placed his resignation with the Industrial Development Authority Board, representing District 5. # BOARD OF DIRECTORS YAVAPAI COUNTY JAIL DISTRICT Minutes of Meeting May 3, 2017

The Board of Supervisors resolved into the Board of Directors of the Yavapai County Jail District.

Present: Thomas Thurman, Chairman; Rowle P. Simmons, Vice-Chairman; Randy Garrison, Member; Craig L. Brown, Member; Jack R. Smith, Member.

Also present: Phil Bourdon, County Administrator; Martin Brennan, Board Counsel; Kim Kapin, Clerk of the Board.

34. Yavapai County Jail District – The Board of Supervisors will resolve into the Board of Directors of the Yavapai County Jail District and following consideration of this item will reconvene as the Board of Supervisors. Approve agreement with Securus Technologies, Inc., to provide an Inmate Phone System, Video Visitation Services, and a Kiosk package within the Yavapai County Detention facility. This agreement is for a term of seven (7) years with up to three successive one-year terms thereafter.

Chief Deputy Rhodes said one of the most important features in the jail was the phone system. He noted the Sheriff had been creative and innovative to recoup revenues and offset some of the costs to the tax payer. He said the contract would allow \$122,000.00 to be recovered per year, which would go into an inmate-program account that funded five positions, inmate programs, educational opportunities and post-duress diversion. He noted there were features in the system that included; biometrics, voice recognition, and jail recorded phone calls. He said it was a good partnership with private industry.

Steven Young, Securus Technologies representative, said the system provided law enforcement the tools they needed to make the facilities safe and noted it was well received across the nation. He stated Securus owned and maintained the equipment for the life of the contract and that an administrator would be onsite 40 hours per week to help ensure the system was functioning properly.

Director Brown mentioned the system was a great deal for everyone.

Mr. Young said the system was a no cost solution for the County.

DIRECTOR BROWN MOTIONED TO APPROVE AGREEMENT WITH SECURUS TECHNOLOGIES, INC., TO PROVIDE AN INMATE PHONE SYSTEM, VIDEO VISITATION SERVICES, AND A KIOSK PACKAGE WITHIN THE YAVAPAI COUNTY DETENTION FACILITY; FOR A TERM OF SEVEN (7) YEARS WITH UP TO THREE SUCCESSIVE ONE-YEAR TERMS THEREAFTER; SECONDED BY VICE CHAIRMAN SIMMONS; PASSED UNANIMOUSLY.

VICE CHAIRMAN SIMMONS MOTIONED TO APPROVE THE CONSENT AGENDA ITEMS 1-34; EXCEPT ITEMS 8, 33 AND 34; SECONDED BY SUPERVISOR SMITH; PASSED UNANIMOUSLY.

### **ACTION**

Action Items 1-3 taken out of order and heard prior to the Consent Agenda.

1. **Board of Supervisors** – Approve a Proclamation declaring the month of May as

"Wildfire Community Preparedness Month." A presentation will follow from Robert Betts, Chairman, Prescott Area Urban Wildland Urban Interface Commission, on firewise/fire prevention and inter-agency cooperation for fuel mitigation.

Robert Betts, Chairman of the Prescott Area Wildland Urban Interface Commission (PAWUIC), introduced Fire Marshall Rick Chase.

Kim Kapin, Clerk of the Board, read the proclamation.

Mr. Betts announced those who were present, including: Scott Freitag, Chief of Central Arizona Fire and Medical Authority (CAFMA); Dennis Light, Chief of Prescott Fire Department; Don Devendorff, Fire Marshall; Pete Gordon, Fire Staff Officer for the Prescott National Forest; Assistant Chief Ron Chilston from the Jerome Fire Department; Jake Gaudiana, Southwest Fire Fighter of the Year and Assistant Fire Manager for the Department of Forestry and Fire Management; and James Robins, Fuel Mitigations Crew Coordinator.

Fire Marshall Rick Chase presented a PowerPoint that included the following:

- What we do
  - Teach residents with defensible space property assessments
  - Educate residents: websites, radio PSA's, newspaper, and One Less Spark campaign
  - Work with PAWUIC grants, Firewise communities, education, collaboration
  - Collaborate with local resources such as: YCSO, U.S. Forest Service, State Forestry, Yavapai County Emergency Management, County Board of Supervisors, and other area fire departments
- Teach Our Residents
  - Develop defensible space around homes
- Home ignition zones
- Educate residents
  - Living with Wildfire booklet
  - Ready Set, Go program
- Educate and inform residents
  - Code Red public sign up for emergency notifications
- Collaborate
  - Annual drill with local agencies
  - Automatic aid with Prescott Fire Department
  - Mutual aid with Prescott National Forest, Williamson Valley Fire District, Mayer Fire Department, Arizona State Land, and Groom Creek Fire Department
- What can you do?
  - o Defensible space around your home
  - Provide good access to your home

- Provide address numbers
- Know when the area is in fire restrictions
- Be careful with burn permits
- Use caution when welding, grinding, cutting, mowing and weed trimming

Supervisor Brown said he enjoyed the fact that the Board had a close relationship with the different fire districts and fire departments.

Chairman Thurman expressed the need to have defensible space.

Supervisor Smith talked about the Walker area and the slash problem. He thanked the County for helping the people of Walker through additional chipping.

Fire Chief Scott Freitag, Central Arizona Fire Medical Authority (CAFMA), talked about the fire in the Upper Blue Hills area the previous night and spoke about the sharing of facilities amongst the different fire agencies.

Supervisor Smith discussed the Fire Ops 101 Program. He noted a conversation he had with Chief Freitag about legislation as to fire operations and how he was able to help influence the vote at the County Supervisor's Association (CSA) regarding legislation that would have affected the fire agencies.

The Board presented the proclamation.

SUPERVISOR BROWN MOTIONED TO APPROVE A PROCLAMATION DECLARING THE MONTH OF MAY AS "WILDFIRE COMMUNITY PREPAREDNESS MONTH"; SECONDED BY VICE CHAIRMAN SIMMONS; PASSED UNANIMOUSLY.

2. **Board of Supervisors** – Approve a Proclamation for 100 years of community service to the Lions Club International, for the Prescott Noon Lions Club.

Chuck Matthews, President of Prescott Noon Lions Club, discussed the background of the club and said they were celebrating 100 years of service. He said the Prescott Noon Lions Club donated \$35,000 to local charities the previous month. Mr. Matthews stated the Club planned to serve the community and donate as much time and money as they could.

Chairman Thurman read the proclamation and the Board presented the proclamation to the Prescott Noon Lions Club.

VICE CHAIRMAN SIMMONS MOTIONED TO APPROVE A PROCLAMATION FOR 100 YEARS OF COMMUNITY SERVICE TO THE LIONS CLUB INTERNATIONAL, FOR THE PRESCOTT NOON LIONS CLUB; SECONDED BY SUPERVISOR BROWN; PASSED UNANIMOUSLY.

3. **Board of Supervisors** – Approve a Proclamation declaring May 15-20, 2017, as National Police Week.

Sherri Hanna thanked the Board for their support of the proclamation for Police Week. She said her family was very involved in law enforcement.

Vice Chairman Simmons read the proclamation.

Lieutenant Kevin Perlach, Prescott Police Department; Chief Deputy Sheriff David Rhodes; and Captain Jeff Newnum, County Sheriff's Department, addressed the Board.

The Board presented the proclamation.

SUPERVISOR BROWN MOTIONED TO APPROVE A PROCLAMATION DECLARING MAY 15-20, 2017, AS NATIONAL POLICE WEEK; SECONDED BY VICE CHAIRMAN SIMMONS; PASSED UNANIMOUSLY.

4. **Board of Supervisors** – Discussion and possible action in regards to a Yavapai County Citizen's Academy.

Supervisor Smith discussed the item. He noted it would be a 10-week academy. He believed it was a starting point and requested the Board's input.

Supervisor Brown commended Supervisor Smith for putting the book together. He asked about the cost, coordination, teaching, meals and if overtime was going to be paid to staff for conducting the presentations. He said he held 12 town hall meetings per year and felt the program was redundant. He asked if the academy would be held on both sides of the hill.

Supervisor Smith affirmed that the academy would be held on both sides of the hill. He stated he utilized the model from Prescott Valley's Citizen's Academy and said they ran their program four times a year. He explained how the program would work. He noted there would be a cost component in order to provide dinner for the participants and instructors.

Vice Chairman Simmons shared his concern that there were already town hall meetings and that department heads often attended the meetings after working long days. He asked if Supervisor Smith had spoken to the department heads about the academy and if they were on board with the idea; Supervisor Smith said most departments were excited about the program.

Chairman Thurman had a concern if there was not a good turnout and believed the Public Information Officer (PIO) should run the program. He suggested tabling the item until the PIO was hired and the cost arranged, and then the item could be brought forward

to the Board for approval.

Supervisor Brown said there should be a study group to discuss the policies and procedures for the use of the PIO; Phil Bourdon, County Administrator, said the Board suggested and approved that the PIO work for the County Administrator and said he would be glad to coordinate the Citizen's Academy with the PIO at the Board's direction.

Chairman Thurman said he would like to see community associations be a part of the academy.

Supervisor Garrison said he appreciated the program. He noted he attended two police academies in the Verde Valley. He believed the academy would be a good way to provide the public with an understanding of the various functions of the County and to know where their tax dollars were spent. He agreed that the PIO should run the program.

Chairman Thurman directed Mr. Bourdon and Supervisor Smith to work on the item.

Mr. Bourdon clarified that he was directed to work on the project with Supervisor Smith and bring the item back to the Board for consideration; Chairman Thurman affirmed.

Supervisor Smith stated the academy classes would have a minimum of 25-30 people.

Supervisor Brown was concerned how the program would work in a rural environment.

5. **Board of Supervisors** – Discussion and possible action regarding legislative updates.

Supervisor Smith presented a PowerPoint regarding the Legislative updates as of May 3, 2017, which included:

- Budget Update
  - The actual budget bills were submitted to the Governor previous night
    - HURF: Restored an additional \$30 million of HURF funds to local governments. The item was restored as an on-going item.
    - Arizona Department of Juvenile Corrections (ADJC): \$8 million in relief for FY18. One-time funding.
    - In-Lieu Lottery: 10 counties remain in the baseline, and \$1.7 million was added to include Mohave, Yavapai and Pinal (\$550,000.00 per county). The new piece was programmed as one-time.
    - Governor's University bonding. There was no impact to counties.
       The universities would receive \$27 million in general funds beginning in FY19 and going forward.
